Caitlyn Carpenter is a Staff Attorney at the Neighborhood Defender Service of Harlem (NDS), first joining NDS in September 2015 as a Skadden Fellow with the Family Defense Team. She received her J.D. from Columbia Law School. While in law school, Caitlyn participated in the Child Advocacy Clinic and received the Jane Marks Murphy Prize for Achievement in Clinical Offerings and the Ruth Bader Ginsburg Prize for Academic Achievement. Prior to NDS, she was a legal intern at the Legal Aid Society in the Bronx and Lawyers for Children.

Adele Fine is presently Bureau Chief of the Family Court Bureau of the Monroe County Public Defender's Office in Rochester, NY. Her office represents indigent litigants in all family court matters for which assigned counsel is statutorily mandated, including custody/visitation, family offense, paternity/child support violation, and child abuse and neglect matters. Ms. Fine graduated from the University of Montana School of Law in 1987. She practiced poverty, family and Indian law in Havre, Montana as an attorney with Montana Legal Services. Upon admission to the New York bar in 1990, she worked in a small firm practicing plaintiff's personal injury, small business and discrimination law. In 1995 she became the Executive Director of a not-for-profit firm representing lowincome clients in Family Court and Supreme Court matrimonial matters. She oversaw the merger of that firm with the Legal Aid Society of Rochester in 1998. She then joined the Family Court Bureau of the Public Defender's Office in 2000, and hasn't left yet.

Nancy Ginsburg is Director of the Adolescent Intervention and Diversion Project in the Criminal Practice of The Legal Aid Society in New York City. She is responsible for supervising and training lawyers in the area of adolescent practice and educational advocacy throughout the five borough offices of the Criminal Practice of The Legal Aid Society. She is responsible for legislative and policy issues concerning court-involved adolescent clients in the adult Criminal Court system. She is a member of the Mayor's Leadership Team on School Climate and Discipline and was a member of the

New York City School Justice Partnership Task Force, the New York City Council Gun Violence Task Force, and the Task Force on the Future of Probation in New York State. Ms. Ginsburg was recently appointed to the New York State Raise the Age Implementation Task Force.

Timothy Murphy is the Chief Attorney for the Appeals and Post-Conviction Unit of the Legal Aid Bureau of Buffalo, Inc., which represents half of the counties in the Eighth Judicial District. Mr. Murphy is Chair of the Appellate Practice Committee for the Bar Association of Erie County, a Director of the New York Association of Criminal Defense Lawyers (and a member of its amicus curiae committee), and Co-Chair of the New York State Bar Committee on Courts of Appellate Jurisdiction.

Sheila Shea is the Director of the Mental Hygiene Legal Service, Third Judicial Department having been appointed to the Service in 1987 and serving as its Director since 2007. She is the author of "The Mental Hygiene Legal Service at 50; A Retrospective and Prospective Examination of Advocacy for People with Disabilities," published by the NYSBA Government, Law and Policy Journal (Winter 2012) and "Representing Clients With Mental Disabilities," published by the New York State Defenders Association Public Defense Backup Center REPORT (January-April 2013). Ms. Shea is the recipient of the 2013 Hodgson/Jacobs Law Award presented by the NYSARC Inc. for demonstrating outstanding commitment and dedication to improving the lives of people who have intellectual and other developmental disabilities and the 2014 Cerebral Palsy Associations of New York Public Service Award.
